Description: A single family residence designed in the Gothic Style. The main roof is a steeply pitched Side-facing gable, with two steeply pitched gable dormers. The dormers have short balconies. The windows have leaded-glass upper sashes and carved detailed panels above (similar to a crest design). There is a brick chimney to the upper right roof edge. To the right is a roof balcony extension with an open roof structure of Japanese influence. To the right rear is a gable extension with a shed-roof dormer. The main roof extends down to form a covered porch, supported on pairs of round tapered columns. The main entrance is centered on the facade. To the far left is a large window flanked by two narrow windows. To the right of the door is a small upper window, and to the far right is a one-over-one window. To the left rear side a two-story bay turret (with roof removed). The dormers are clad in wood shingle, and the main floor is clad in horizontal wood clapboard.

Cultural Data: Home of Frederick H. Murray, an attorney whose offices were in the Equitable Building. The house was completed at a cost of \$15,000 and the construction is described as "...most pleasing, the arrangement artistic." The basement contained a furnace, fuel room, sewing room, toilets and bedroom. The main floor included "...a reception hall, library, parlor, dining room, conservatory, etc..." The house was converted to a treatment center for Alcoholism in the 1930's. It is currently in use as an apartment building. Spalding, Russell & Heath, architects. 1901

The dormer has a pair of narrow rectangular windows. There are brick chimneys to the left and right rear of the roof. A covered porch supported on round tapered columns extends across the front. At the main level there is a three-paneled by window to the left side. The main door is centered and there are three one-over-one, double hung windows along the front. The walls are clad in horizontal wood clapboard.

Cultural Data: Home of Ellis Lewis Garretson, a businessman whose firm provided Legal and Notary Republic services and offered general insurance, and was located in the Fidelity Building. Garretson was born in 1872 in Victor, Iowa, and attended Hill Military Academy as a young boy. He came to Tacoma in 1880 and began his law practice as a 21-year-old. In 1920, Garretson, who was heavily involved in the Afifi Temple, was elected "imperial potentate of the Mystic Shrine of North America..." He served as the head of the Shrine of North America for only a year and a half before his death. He died of a sudden heart attack in the early morning and was only 49 years of age. Original architect, builder and contractor unknown. 1900

Description: A single family residence designed in the Queen Anne Style. The main roof is a front-facing gable with returned eaves and a side dormer to the right. The upper portion of the main gable front is set out from the main wall. There is a pair of one-over-one, double hung windows with decorative shutters at the upper floor. There is a brick chimney to the left side. A hip-roofed porch supported on round columns extends across the main floor. The door is located right of center, and to the far right there is a small square window. To the left is a large grouping of windows; a large central window divided by a single vertical mullion, flanked by two one-over-one, double hung narrower window. The structure is clad in wood shingle.

Cultural Data: Home of Edwin R. Ray, a printer whose company was located at 113 S. 13th Street Ray came to Tacoma after reading a promotional letter by Allen C. Mason that had been printed in the Street Louis Globe-Democrat. Born in Lexington, Tennessee in 1866, his family moved back to their home state of Kentucky when he was still a small child. Ray's father was a Baptist minister and operated a paper, "The American Baptist". Edwin learned the printing trade in his father's office. His formal schooling was cut short by illness, and he would later say that the education he received in the print shop was the "best of its kind as far as it goes." When he arrived in Tacoma, 24 years old, he worked on the Morning Globe, one of Tacoma's earlier papers, but started his own print shop in 1892. He and his wife Marguerite had one son. An October 1905 Ledger article describes an unusual burglary at the Ray home in which the suspect broke into the home while the owners were out of town, turned on all the lights and made off with such valuables as one pair of (old) socks, two pairs of scissors, one box of tooth powder and one copy of Bryant's poems. The "plunder" was discovered a week later with a vast collection of stolen items, including "...socks and stockings enough to start a store- hundreds of them..." The thief had hidden everything in a "dense thicket" near L and South 7th streets. Original architect, builder and contractor unknown. 1904

Cultural Data: Next door and not there anymore. 423 North Sheridan Avenue Home of William C. Davie, a railroad contractor whose office was located at 304 California Block. William M. Davie (probably a son) also resides here. William Davie was born in Wisconsin, and came to Tacoma in 1893. While the railroad was under construction to the Puget Sound, he worked as a purchasing agent for the Northern Pacific Railroad, covering the Dakotas and Montana. Once in Tacoma, he began working for the Tacoma Fir Door Co., and then later operated the Chehalis River Lumber Co. He was considered one of the pioneer lumbermen of Tacoma. After his retirement he took up residence in Steilacoom. Interestingly enough, Davie's home was the first residential job A. J. Russell received when he opened up his practice here in Tacoma. Russell estimated the house to cost \$1,600. Ambrose J. Russell, architect. 1895

Upstairs, in addition to four bedrooms and a bathroom, was an attic with "...a large room fitted for servants quarters." Original architect, builder and contractor unknown. 1904

Cultural Data: Home of Peter Voorhees, occupation unlisted. This house was estimated to cost \$3,500 and would be "...finished in redwood." Voorhees was born in Harlington, Somerset county, New Jersey in 1832. He married Molly Lloyd and they settled in Detroit, Michigan. He was involved in the grocery business initially, which would lead to the founding of Henkel & Voorhees, a flouring mill. He arrived in Tacoma in 1890, and decided to build a mill and elevator right away. However, the economic depression forced him to put a hold on his plans. He would pass away in 1902, at the age of 70, never having succeeded in establishing a business in Tacoma. He and his wife had three daughters. Ernest L. Sawyer, builder. O. P.
