We're Going National

The National Historic Preservation act of 1966, created the National Register of Historic Places, the official roster of properties significant in illustrating the heritage of the United States. Today, more than 62,000 properties are listed in the register, which is maintained by the National Park Service. Listing in the National Register contributes to preserving historic properties in a number of ways:

- Recognition that a property is of significance to the Nation, State, or community.
- Consideration in the planning for Federal or federally-assisted projects.
- Eligibility for Federal tax benefits.

- Qualification for Federal assistance for historic preservation, when funds are available.
- Eligibility for certain tax provisions

Listing honors our homes and our district by recognizing its importance to our community's history. It is the city-recognized District that would be "Going National", with all of our homes included. Roger Johnson , our representative on the Landmarks Commission, summed it up for us when he said, "Designation as a National Historic District will add another layer to our already rich historic district." The fact that we are already a Tacoma Historic District makes the process of submitting the application to the state a lot less time-consuming; the research has already been done. All additional work will be performed by volunteers.

Our nomination, after a sign-off by the Tacoma's Landmarks Commission, will be submitted to the Washington State Office of Historic Preservation for review. After the state review board approves the nomination, it is sent to the National Park Service to be considered for listing. When our district is approved by the National Park Service, it is officially entered in the National Register. This process takes months.

The Criteria for evaluating the NSHD for eligibility are that the properties and homes are associated with events that have made a significant contribution to the broad patterns of our history, and that the properties embody the distinctive characteristics of a type, period, or method of construction. Owners of listed properties may be able to obtain Federal historic preservation funding, when funds are available. Tax credits for rehabilitation and other provisions may apply.



One of the most common questions that property owners have about the National Register is, "Will there be restrictions on my property after listing?" There is no downside to being on the register. A direct quote from the National Park Service: "Under federal law, owners of private property listed in the National Register are free to maintain, manage, or dispose of their property as they choose provided that there is no Federal involvement." (In our case, we are the North Slope Historic District, a City of Tacoma District, so the building review commitments of our local Tacoma district still apply.)

There are about 950 real-estate properties to evaluate and the National Park Service requires that we look at ALL OF THEM. That is being done now, which is a very time-consuming data-processing project. The application also requires photographs of all the different types of properties, both contributing and non-contributing. Secondary structures, like the detached garages, will be included too. All this must be done in National Park Service format and according to National Park guidelines.

Salmon Stickers

About 30 volunteers installed over 200 plastic curb markers by North Slope storm drains Saturday, July

20. The markers, showing a salmon swimming, replace the former stenciled white paint "no dumping" signs.

Whatever flows into Tacoma's storm drains--oil, paint, soap, pesticides, pet litter---goes
directly into our local waterways. This
pollution hurts salmon and other aquatic
animals. The City of Tacoma Environmental
Services and Citizens for a Healthy Bay
sponsored the two hour work party, and
provided pizza and drinks afterwards.
If you haven't seen the markers, look for the
colorful (blue, pink, white) 3"x5 1/2" oval

markers on the curbs above drains.

At the July 9 police/community meeting, Tacoma's Crime Free Housing program was discussed. The next training for property managers, realtors, and owners of rental units will be October 15 and 16. For information about the free program designed to decrease criminal activity on rental property call Mary Beth Riggs, 591-5160. The training discusses screening, drug and nuisance abatement, and resources.

Tacoma is participating in the national program, "Watch Your Car." By registering with the anti-theft plan, vehicle owners certify they are not normally on the road between 1 and 5 a.m., and authorize law enforcement officers to pull over the car if being driven then.
